Cremation is Not the End ...

... It is Preparation for Memorialization

Each year on Memorial Day in the United States and Remembrance Day in Canada, thousands of individuals travel to local cemeteries and memorial parks to pay their respects to departed family members and friends. This once-a-year event, originally established to honor our war dead, signals the time for taking plants to gravesites, placing flowers in vases, and meditating in churches and chapels.

Visits to final resting places, however, are not limited to just this one day. Throughout the year people remember those who are no longer with them by going to the areas where special memorials have been established.

Remembering those who have died is not a modern-day phenomenon. Thousands of years ago when the funeral pyre and the "sacred flame" were used, survivors fashioned beautiful urns to hold the cherished remains from what they termed the "purifying fire."

Today, cremation has advanced from the crude funeral pyre to modern scientific methods. It is only in the handling of those "cherished remains" that we link up with the past.

We recognize, as did those individuals long ago, the importance of memorialization.

***Cremated remains should NEVER be
mailed to the cemetery office.***

Cremation Committal Services when arranged by families

Catholic Cemeteries encourages cremation burial to follow the same process as a funeral with a casket. Use of a funeral director's services, funeral mass at the parish, and a blessing at the grave-side, crypt or cremation niche is recommended and encouraged.

However, cremation affords families the occasion to handle burial arrangements without the assistance of a funeral director. For these arrangements, the following procedures and guidelines are recommended for your review.

Before purchasing a cremation urn, families should review the cemetery's rules and regulations regarding the appropriateness of the container and the maximum permitted urn size for the intended burial space.

INURNMENT IN A CREMATION NICHE

- Review the regulations for your niche type which are specified in the printed rules signed at the time of purchase.
- **Glass front cremation niches** have additional restrictions concerning overall characteristics of urn type, composition, inscription and epitaphs on the urn to be displayed.

INURNMENT IN A CEMETERY PLOT

- Confirm cemetery requirements prior to purchasing an urn.
- All urns are placed in a vault prior to burial and the **maximum urn size should not exceed 12.5" Long x 6" High x 7.5" Wide.**

Families should appoint one member as a spokesperson to contact the cemetery office to make arrangements. Please contact the cemetery **one to two weeks before** the intended burial date.

Before contacting the cemetery office to make arrangements, family members may wish to locate and review the following:

1. Home parish/funeral liturgy information;
2. Cemetery certificate;
3. Cremation certificate;
4. Urn type selected, its size, and review the restrictions for the burial space.
5. Additional concerns: Select an acceptable inurnment date for both family and cemetery schedule. Is the selected time a recommended burial time for the cemetery or will it warrant additional overtime charges?
6. Will this service be conducted in the cemetery chapel and conclude there? Or will the service take place next to the burial site? (Families may choose one, but not both places).
7. Do you wish to have clergy present for the committal service?
8. Determine amount and method for payment of required inurnment fees.
9. Since people may arrive separately rather than in a traditional funeral procession, it is recommended that all attendees be informed of the exact service location and gathering time. It is **not** recommended to just arrive at the cemetery or ask family members to call the cemetery office for this information.

IMPORTANT INFORMATION

Families are **REQUIRED to PRE-PAY ALL FEES AND SUBMIT ALL REQUIRED PAPERWORK to the cemetery office at least one week in advance of the committal date.** Fees may be paid by cash, certified check, debit, or credit card. A committal service will not be scheduled unless this step is completed.

ADDITIONAL CONCERNS: Overtime charges may apply based on the time the funeral arrives at the cemetery office. Incidental fees, e.g. affidavit processing, may also apply. Families should be prepared to pay these charges in full prior to inurnment. Cancellation fees will apply for cancelling a scheduled committal service.

CHECKLIST: ITEMS TO PRESENT AT CEMETERY FOR COMMITTAL SERVICE

- Original Cemetery Certificate (Deed) OR Signed/Notarized Permit to Open Affidavit**
 - Photocopies of certificate not acceptable
 - If original certificate not available, cemetery will provide affidavit to be signed/notarized
- Original Cremation Certificate**
 - Usually comes in box with remains from crematory
- Signed & Notarized Committal Letter**
 - Affidavit provided by cemetery to be completed by current certificate holder or next of kin
- Payment for all cemetery fees**
 - Credit/Debit Card (MasterCard, Visa, or Discover), Cash or Certified/Bank Check only.
- Cremated Remains in Appropriate Urn**
 - Refer to brochure for urn requirements
 - Standard container from crematory is acceptable **unless** remains are being inurned in a glass niche
- Priest Line Certificate (when required)**
 - Document from parish church or hospital chaplain confirming eligibility for burial in Catholic cemetery
